

# Privacy Policy

Our Privacy Policy was last updated on October 22, 2025

This Privacy Policy describes Our policies and procedures on the collection, use, and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

## Interpretation and Definitions

### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

### Definitions

For the purposes of this Privacy Policy:

- **"Account"** means a unique account created for You to access our Service or parts of our Service.
- **"Company"** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Atlas TransIntel, LLC, 4620 Henry St, Pittsburgh, PA, 15213, United States.
- **"Cookies"** are small files that are placed on Your computer, mobile device, or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- **"Country"** refers to: United States
- **"Device"** means any device that can access the Service such as a computer, a cell phone, or a digital tablet.
- **"Personal Data"** is any information that relates to an identified or identifiable individual.
- **"Service"** refers to the Website.
- **"Service Provider"** means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service, or to assist the Company in analyzing how the Service is used.
- **"Usage Data"** refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).
- **"User-Generated Content"** refers to any content, such as project descriptions, images, comments, or profile information, that You submit to be displayed on the Service.

- **"Website"** refers to Projects Yard, accessible from <https://projectsyard.com>
- **"You"** means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

## Collecting and Using Your Personal Data

### Types of Data Collected

#### Personal Data

While using Our Service, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally identifiable information may include, but is not limited to:

#### Usage Data

Usage Data is collected automatically when using the Service.

### Tracking Technologies and Cookies

We use Cookies and similar tracking technologies to track the activity on Our Service and store certain information. Tracking technologies used are beacons, tags, and scripts to collect and track information and to improve and analyze Our Service.

You can instruct Your browser to refuse all Cookies or to indicate when a Cookie is being sent. However, if You do not accept Cookies, You may not be able to use some parts of our Service.

Cookies can be "Persistent" or "Session" Cookies. Persistent Cookies remain on your personal computer or mobile device when You go offline, while Session Cookies are deleted as soon as You close your web browser.

We use both session and persistent Cookies for the purposes set out below:

- **Necessary / Essential Cookies**
  - Type: Session Cookies
  - Administered by: Us
  - Purpose: These Cookies are essential to provide You with services available through

the Website and to enable You to use some of its features. They help to authenticate users and prevent fraudulent use of user accounts.

- **Functionality Cookies**
  - Type: Persistent Cookies
  - Administered by: Us
  - Purpose: These Cookies allow us to remember choices You make when You use the Website, such as remembering your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience.
- **Analytics and Performance Cookies**
  - Type: Persistent Cookies
  - Administered by: Third-Parties (e.g., Google Analytics)
  - Purpose: These Cookies are used to track information about traffic to the Website and how users use the Website.

## Use of Your Personal Data

The Company may use Personal Data for the following purposes:

- **To provide and maintain our Service,** including to monitor the usage of our Service.
- **To manage Your Account:** to manage Your registration as a user of the Service. The Personal Data You provide can give You access to different functionalities of the Service that are available to You as a registered user.
- **To display Your User-Generated Content:** to publish your projects, comments, and profile information to be seen by other users and the public.
- **To contact You:** To contact You by email regarding updates or informative communications related to the functionalities, products, or contracted services, including security updates.
- **To provide You** with news, special offers, and general information about other goods, services, and events which we offer.
- **To manage Your requests:** To attend and manage Your requests to Us.
- **For business transfers:** We may use Your information to evaluate or conduct a merger, divestiture, restructuring, or other sale or transfer of some or all of Our assets.
- **For other purposes:** such as data analysis, identifying usage trends, and to evaluate and improve our Service, products, services, marketing, and your experience.

## Sharing Your Personal Data

We may share Your personal information in the following situations:

- **With other users and the public:** When You share personal information, submit User-Generated Content, or otherwise interact in the public areas with other users, such information (like your username, profile picture, and projects) may be viewed by all users and may be publicly distributed outside.
- **With Service Providers:** We may share Your personal information with Service Providers to monitor and analyze the use of our Service and to contact You.
- **For business transfers:** We may share or transfer Your personal information in

connection with any merger, sale of Company assets, financing, or acquisition of all or a portion of Our business to another company.

- **With Your consent:** We may disclose Your personal information for any other purpose with Your consent.

## **Retention of Your Personal Data**

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will also retain Usage Data for internal analysis purposes.

## **Transfer of Your Personal Data**

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. This means that this information may be transferred to computers located outside of Your state or country.

Your consent to this Privacy Policy followed by Your submission of such information represents Your agreement to that transfer.

## **Disclosure of Your Personal Data**

The Company may disclose Your Personal Data in the good faith belief that such action is necessary to:

- Comply with a legal obligation
- Protect and defend the rights or property of the Company
- Prevent or investigate possible wrongdoing in connection with the Service
- Protect the personal safety of Users of the Service or the public
- Protect against legal liability

## **Security of Your Personal Data**

The security of Your Personal Data is important to Us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While We strive to use commercially acceptable means to protect Your Personal Data, We cannot guarantee its absolute security.

## **Children's Privacy**
